Data we process:

Eurotape processes your data because you use our services and/or because you provide it to us yourself.

Special and/or sensitive data that we process:

Eurotape does not process special and/or sensitive data.

For what purpose and on what basis we process data:

Eurotape processes your data to:

- handle your payment;

- inform you about changes to our services and products;
- deliver goods and services to you.

Automated decision-making:

How long we store data:

Eurotape will not retain your data for longer than is strictly necessary to achieve the purposes for which your data is collected.

Sharing of data with third parties:

Eurotape only uses technical, functional and analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your convenience. They ensure that the website works correctly and remember information, such as your preferences. In addition, they enable us to optimize our website. You can opt out of cookies by setting your internet browser to prevent cookies from being stored. In addition, you can also delete all information previously stored through your browser's settings.

Accessing, modifying or erasing data:

In this copy, please blacken your passport photo, MRZ (Machine Readable Zone, the strip with numbers at the bottom of the passport), passport number and BSN (Citizen Service Number). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
