

Reusable face mask

Washable and reusable mouth-nose protection masks with membrane system

The washable mouth mask is made to protect yourself against harmful particles that can be transported by air. The reusable mouth-nose protection mask is made of medical fabric with a barrier membrane. The used materials comply with the requirements of EN 13795: 2019 "surgical drapes and gowns - requirements and test methods"

The materials of these masks have been used for many years in reusable surgical gowns and drapes. They also have been tested for the resistance to microbial penetration. Corresponding test reports are available.

Advantages of the reusable mouth-nose mask:

- Barrier membrane regains its protective properties after washing at 60°
- reduction of (medical) waste due to the reusable nature of the fabric

Available in the colors light blue, green, grey and white.



Hold the mask by the ear loops and place a loop around each ear



Pull the bottom of the mask over your mouth and chin



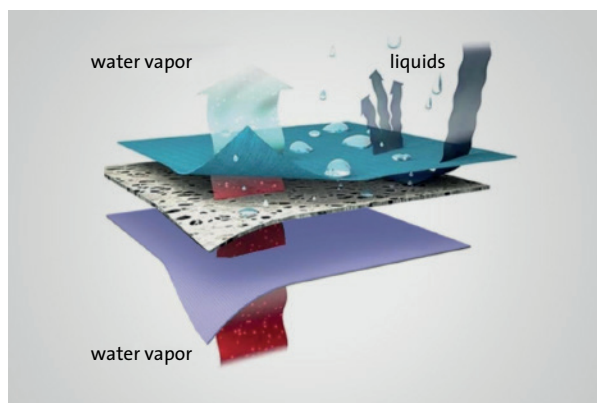
Avoid touching the front of the mask when wearing

Elastics may contain latex
Sewing thread in 100% polyester

Water temperature 60°C



Do not bleach



Low heat



Do not iron



Do not tumble dry

Storage instructions

Store at a temperature that does not exceed 25°C with a maximum relative humidity of 80%. Keep away from light sources. Do not store longer than 1 month at average conditions higher than indicated.

The materials comply with EN 13795: 2019 technical standards "surgical drapes and gowns - requirements and test methods" for performance requirements and ISO 10993-5: 2009 "Biological evaluation of medical devices - Part 5: Tests for in vitro cytotoxicity" for the harmlessness requirements.
